**6.64.530.A.TPO** – Felling of 3 Hawthorn trees within group G1 of Tree Preservation Order 27/2007 – Land Comprising OS Field 9791 Main Street, Minskip, North Yorkshire – *B The Town Council objects on the planning grounds that they form part of the agreed landscaping plan for the field.*

**6.64.583.G.FUL** – Formation of a multi use games area – **Land at Grid Reference 438862 464975 Main Street’ Minskip, North Yorkshire** – *C The Town Council does not object to or support the application but wishes to make the following comment.....the Town Council supports the principle of MUGA, subject to implementation of existing approved landscaping plan for the Community Hall and Recreation area being carried out either before or in conjunction with the construction of MUGA*
