**NOTE**: The right to erect a headstone or monument exceeding 1 metre in height, footstones, kerb or border stones, rails, chains or palisades or tablets is no longer permitted.

Plans and designs for all headstones, monuments and inscriptions must be submitted to the Council for approval.

The 20% discount on the above fees on the exclusive rights of burial and interment fees applies where the person to be interred was an inhabitant or parishioner of the parishes of Boroughbridge, Langthorpe, Ellenthorpe, Humberton and Milby or, in the case of a still-born child, where either of the parents is or was at the time of interment such an inhabitant or parishioner.

The Burial Board to use its discretion on fees where a person was a resident of the parish for some considerable time and then circumstances beyond their control forced them to move.
