B The Town Council objects on the planning grounds set out below:

The Town Council feels this application is totally inappropriate and from the outset has objected to this application in its entirety. Please see previous objections below:

From the outset the Town Council has objected to this application. The proposed increased height of the bridge would be overbearing and would dominate the landscape and would not be in keeping with the area.

The services and sewerage system going into Aldborough sewerage works cannot cope with further increase in volume. We have already seen problems with this over the last few months, leading to flooding.

The Town Council believes the site would be over developed. The height is inappropriate and is intrusive in the local area. The use of additional land for the slip roads will impact negatively on the local area. The proposed development would make the site overly obtrusive in the locality.

The Town Council strongly object to this application. All previous objections and reservations remain and we would reiterate these
