These trees are within Tree Preservation Order 58/2017 and therefore should be protected. The Town Council objects to this application as it would denude this area of green field and would further destroy more of the wildlife habitat. The felling of these trees were not on the original site plan and the Town Council strongly object to them being taken down.

B The Town Council objects on the planning grounds set out below:

This Council has objected to this application from the onset and this Reserved Matters application is not in keeping with the original outline application.

The Town Council have concerns regarding the height of the proposed bridge, which would have a visual impact on the local area. The green roofs which were a key aspect of the landscape approval seems to now be omitted from the plan. The Town Council also raise concerns about the proposed increase in height of the eastern dumb-bell roundabout. The original plan proposed no development on the eastern side of the A1(M) near to the village of Kirby Hill. The Reserved Matters application now shows a field to the east of the A1(M) with several man-made surface Water drainage lagoons and ditches along the whole length. The layout of the built development Has encroached on the eastern side of the A1(M).

The Town Council strongly object to this application in its entirety. This Reserved Matters Application materially increases the scope, scale and harm of the development compared to what Was approved at outline stage.
